

IMPORTANT INFORMATION ON VISA REQUIREMENTS FOR FOREIGN NATIONALS

Foreign nationals wishing to enter the country fall within one of the three (3) distinct categories with regards visa requirements depending on their countries' bilateral agreements/arrangements with Zambia while some are placed in a particular category purely on reciprocity. The categories include:

- Nationals who do not require visas in order to enter Zambia
- Nationals that can obtain Visa at Port of Entry or from Embassy
- Nationals required to apply for Visas prior to their travel to Zambia

NOTE: While Applicants in category 3 below, should also submit all other visa application requirements, payment of visa fees should only be made once clearance has been confirmed.
